Minutes: Motion by Jane Gignac, 2nd by Troy Frank, to approve minutes as mailed. Passed.

President's Report: Slug reported all county trails are closed because of the spring breakup, even though some county areas received a blizzard snowfall.

Treasurer's Report: Andy gave the club's financial report. Motion by Mack McKim, 2nd by Gerry Zore, to accept the report. Passed.

Committee Reports: Alliance – Slug reported on the Alliance meeting with the county's Park & Forestry members held on March 26, 2018. At the Alliance meeting on April 9, 2018, the Alliance map sheets were handed out. Pat Mullarky was elected Vice President of the Alliance and all other officers were returned to their office. The county's snowmobile liaison officer, Dave Ogenski, reported on the county's patrol activity this last season. The officers logged 207.5 hours of snowmobile activity with 158 hours of patrol; 25 citations were issued, 18 warnings, and 2 very expensive arrests for fleeing an officer.

Legislative – Nothing new on the legislative front at this time.

Membership – Thank you to our renewing business members. Andy gave the club's membership report.

Clean-up – Ron Rost stated because of the weather conditions, the road clean-up scheduled for after this meeting has been cancelled and will be done by our volunteers in the next couple of weeks as the snow and water recede.

Old Business: Slugfeast – Discussion was held on the date for Sllugfeast. Motion by Troy Frank, 2nd by Jane Gignac, to have the event on February 2, 2019, at Bear Point. Passed.

Meat Raffle – Discussion was held on the club's meat raffle. Motion by Mary McKim, 2nd by Troy Frank, to have the meat raffle on March 2, 2019, at Gateway. Slug will be confirming this with Scott at Gateway.

Easter Egg Tree – Slug reported the donations totaled more than \$450 for Pastor Fred's Food Pantry. A big thank you for supporting this project.

New Business: AWSC Convention – Andy reported on the annual meeting of the AWSC. All AWSC officers were re-elected to their offices. There were 565 people in attendance, four scholarships were awarded. The AWSC is working on the planning of the 50th anniversary to be held at the Radisson in Green Bay on March 22-24, 2019. The insurance company, American Income Life, has notified the AWSC that it will not be providing the free insurance policies to AWSC members as in the past. Too many claims and not enough sales. Their \$1,000 scholarship has also been cancelled.

AWSC's Dues and Fees – Discussion was held on increasing the AWSC dues and fees that will be presented to the AWSC Directors. Motion by Troy Frank, 2nd by Ron Rost, to support a dues increase and a registration and banquet fee increase for AWSC Convention and Workshop. Passed.
