## **BEAR POINT SNO-CRUISERS MEETING**

President Slug Radtke called the session to order at 9:55 AM.

Officers Present: Slug Radtke, Ron Rost, Mack McKim, Andy Malecki, Jr., and members of Bear Point Sno-Cruisers. Ken Boren was excused.

Minutes: Motion by Mary McKim, 2<sup>nd</sup> by Troy Frank, to approve minutes as mailed. Passed.

President's Report and Alliance Report: Slug and Andy reported on the trails in the county that the clubs are working to get open. Trails in the northern part of the county are open, but caution is needed because the swamps are not frozen and the last heavy snow storm has many trees down and blocking the trail. We had two Sno-Cruisers members working on a two mile section of trail in the county forest coming to Bear Point and they had to remove over 50 trees off the trail. Also, the weather is preventing the farmers from getting the corn off their fields. The clubs are having to detour some trails because of the water holes and unfrozen swamps. As of this writing, the trails in southern Marinette County are closed and the remainder of the clubs have some trails open and some areas are closed until the trails can be cleared. When you do ride on the open trails, use extreme caution because of the wet areas and trails that have not been groomed. Please, please respect the trails that are closed and detoured. Also please do not put trail equipment problems or situation on social media that you observed as this can affect our snowmobiling sport.

Vice President: No report.

Treasurer's Report: The Sno-Cruisers monthly financial report was given by Andy. Motion by Ron Rost, 2<sup>nd</sup> by Norm Ward, to approve. Passed. Andy also reported the club's insurance has been renewed, the IRS 990 tax form has been filed, and the State Department of Finance form has been filed.
