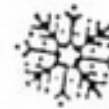

President's Report: Mack reported on the progress the Village of Wausaukee is doing on the building to house the village offices, library, and community center.

Committee Reports: Alliance – The clubs are working on the 2021-2022 snowmobile map.

Legislative – The DNR Board has approved the snowmobile trail proposal for the Blue Mound State Park. The AWSC has worked on this issue for the past 10 years. Legislation has been introduced on the 40 foot trail rule, dimming of headlights, and exhaust sound issues. As of 6/14/21 there have been 250,567 snowmobiles registered in Wisconsin, with almost \$4 million in trail pass revenue.
