Committee Reports: Alliance – The Snowmobile Alliance met on October 2 and proofed the trail side of the map. Ryan Bouressa, County Forester, will be overseeing the trail changes on the map. The map will be forwarded to the printer and hopefully be delivered to Wausaukee on November 6. On October 9, 2023, the Alliance met with the county forestry committee and county officials to explain the procedures for grants. Discussions were held on the benefits that motorized recreation has on the county tourism income. A handout on snowmobiling prepared by the Governor's Council and Tourism Committee was given to the meeting explaining the AWSC and the State's snowmobiling program.

Legislative – The legislature is having a hearing on the legislation proposed by the AWSC. Andy reported on the State Administrative meeting he attended. Some interesting items: Wisconsin has the most snowmobile trails and registered snowmobiles in the nation. Wisconsin has over 20,000 funded miles and over 5,000 non-funded miles. Wisconsin also has more snowmobile trails than state numbered highways. The administrators stated the GPS units used by the clubs have improved grooming and project paperwork.

Membership – Andy gave the membership totals of renewed members and business members. Thank you to all that have renewed their club membership.
