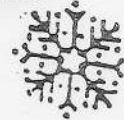

Thank you to Norm Ward for the donation for the picnic.


